

- RAS/SRES in different projects of ICAR Institutes [maximum of 16 years 03 months]. They should have been engaged continuously in different projects of ICAR Institutes without inordinate spell of breaks. An employment certificate indicating the names of the projects and the exact period be/she worked in each project, may be obtained from the Competent Authority and enclosed along with the application. The applications without Employment Certificate and authorite proof will not be entertained. The age relaxation is applicable for the post of T-3/Lechnical Assistant under Direct Recruitment for RAS/SRES only. This dispensation is only for relaxing the maximum age limit and does not imply any other relaxation whatsoever regarding essential qualifications and experience etc.
- 3. Last date for receipt of applications is 2101.2016 (for applicant posted in Andaman and Nicobar Islands, Lakshdweep, Minicoy and Amindeivi Islands, States/Union Territories in the North-Eastern Region, Ladakh Division of J&K State, Sikkim, Pangi is 05.02.2016). Applications received after last date will not be entertained. The Director, CSWRI, Avikanagar reserves the right to cancel the recruitment process at any stage due to one reason or the other.
- 4. Mere possession of higher qualification does not entail any right to any candidate for each of examination. Only short listed candidates will be called for examination.
- 5. Crucial date for determining the age limit of candidates will be the closing date of receipt of applications.
- 6. Community Certificate for SC/ST/OBC may be obtained from the competent authorities in the latest standard format as prescribed by Govt. of India from time to time.
- 7. Candidates Who claim to be Persons with Disability will be required to submit Medical Certificates as per disability in the new prescribed applicable format issued by the Competent Medical Authorities for the Purpose of employment.
- 8. Decuments in support of claim of Ex-Servicemen category should be enclosed along with the application form.
- 9. The post is non-government under the Indian Council of Agricultural Research which will be governed by the New Pension Scheme introduced by the Govt, of India with effect from 01 01.2004 mutatis-mutandis and as amended from time to time.
- 10. The posts are purely temporary but likely to continue.
- 11. For the posts mentioned at St.No. 2, 3 & 4, the Selected candidates will have to undergo one year on-the-job training, which will be provided by the Institute. The selected candidates will be called as Technical Trainee during the training period. After successful completion of the one year training, a certificate to this effect will be provided by the Director of the Institute and regular appointment will be done.
- 12. The place of posting of selected candidate will be as per their merit at CSWRI, Avikanagar or its sub-stations i.e. SRRC, Mannavanur, Kodaikanal 624 003 (T.N.). NTRS, Garsa 175 i.41, Kullu (H.P.) and ARC, Bikaner 334 006 (Rajasthan). However, appointeds will be liable to serve in any institute of ICAR anywhere in India.
- 13. The candidates who are in service in the Central/State Govt/Undertaking/Autonomous bodies etc. should apply through 'proper channel'.
- 14. The candidate should give declaration in the application form at serial number 10 whether he/she is related/not related to any employee of the CSWRI/ICAR and if so, he/she has to provide the details.
- 15. No TA/DA is admissible for attending the examination
- 16. Applications received after the due date for any reason including postal delays will not be emertained.
