OFFICE ORDER

Dr. Chandan Prakash, Sr. Scientist (DR Scientist in the Veterinary Microbiology discipline) who was on lien upto 23.09.2024 [consequent upon his selection to the Rajasthan Police Service (RPS), at his own request Dr Chandan Prakash had got himself relieved from ICAR service w.e.f. 24.03.2022 (AN) by submitting technical resignation from ARS of ICAR (vide council letter No. 7(1)/2022-Per.
