I am directed to say that the scales of pay of ICAR Scientists were revised vide Council's letter No. 1(4)/2017-Per IV dated 27.3.2018 in the light of scheme of revision of pay of teachers in Centrally Funded Universities and Colleges under the UGC framework notified by the MoHRD pursuant to adoption of recommendations of 7th CPC.

- 2. Subsequently, clarifications have been sought as to whether Dearness Allowance on Non-Practicing Allowance (NPA) is to be considered while fixing the initial pay of Veterinary Scientists in the 7th CPC w.e.f. 1.1.2016.
- 3. The matter has been examined in the Council. It has now been decided with the approval of Competent Authority and concurrence of Internal Finance Division of the Council that the pay of Scientists holding Veterinary qualifications and drawing NPA as on 31.12.2015 shall be fixed as per the method of fixation of revised pay illustrated by the Deptt. of Expenditure, MOF in the Gazette Notification dated 25.07.2016 (Revised Pay Rules, 2016).
