

**CIRCULAR**

As a part of the 125<sup>th</sup> Birth Anniversary of Dr. B.R. Ambedkar celebrations, the 'Constitution Day' was celebrated on 26<sup>th</sup> November, 2015 for the first time and notification regarding the decision of the Govt. of India to celebrate 'Constitution Day' every year was also issued.

This year also, the 'Constitution Day' is being celebrated on 26<sup>th</sup> November, 2016. However, as 26<sup>th</sup> November, 2016 happens to be a holiday, it has been decided by the Govt. of India, Ministry of Social Justice and Empowerment that 'Constitution Day' shall be celebrated on 25<sup>th</sup> November 2016. Accordingly, 'Preamble' to the Constitution shall be read out in the august presence of Director General, ICAR in Committee Room-I at 10.30 AM in Krishi Bhawan. Chairman, ASRB and DDG(Agril. Engg.) shall read out the Preamble at the same time in the Committee Room at KAB-I and KAB-II respectively. The staff of NASC shall join the celebration at KAB-II. However, the Institutes may celebrate the 'Constitution Day' on 26<sup>th</sup> November, 2016 as it is a working day for them.

Officials/employees of ICAR Hqrs. are requested to assemble at the venue for participating/reading out the Preamble. The Preamble to the Constitution alongwith GOI letters dated 07.10.2016 and 15.11.2016 are enclosed herewith.





## THE CONSTITUTION OF INDIA

### PREAMBLE

WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC and to secure to all its citizens:

**JUSTICE**, social, economic and political;

**LIBERTY** of thought, expression, belief, faith and worship;

**EQUALITY** of status and of opportunity;

and to promote among them all

**FRATERNITY** assuring the dignity of the individual and the unity and integrity of the Nation;

IN OUR CONSTITUENT ASSEMBLY this twenty-sixth day of November, 1949, do HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.

Dear Dr. Mohapatra,
