OFFICE ORDER

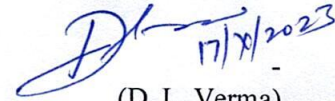

In accordance with council circular No.TS:11(5)/2018/E./IV dated, 30.05.2018 it is informed that if at any time, it is found that the employee is not possessing the requisite qualification required for the respective grade or is not eligible to hold that grade for any administrative reason then he is liable to be placed in the eligible lower grade and recovery of proportionate amount of dues can be made from him by giving show cause notice.
