Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of guoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

## 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 4. Payment

2- If any kind of mishappening during the above work, it will be the responsibility of the firm, only.

3- For the above work, the material / tools etc. will be of the firm itself. 4- If due to the negligence of the fir m, the property of the institution is damaged in the course of w ork, then deduction will be made from its b ill /security money

5- Labor laws have to be followed by the firm.

6- After completing the above work satisfactorily, payment of the bill submitted by you within 30 d ays as per rules- will be done through From which income tax will be deducted as per rules.

8- The Competent authority reserves the right to cancel the above work order at any time without assignin g any reason.

10- The contractor or his deployed workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.

11- The rates to be quoted should include cost of each and every item including material cost if an y, trans portation cost, manpower cost and taxes etc. The CSWRI shall not bear' any extra charge o n any account whatsoever uniform, Liveries, OTA etc, if any'

12- Income Tax GST/TDS shall be deducted from the payments due for the work done as per rule.

13- The Contractor must employ adult labour only. Employment of child labour would lead to the te rminati on of the Contract beside legal action as per Law.

14- The Payment fo the labour engaged shall be in accordance of the labour laws for which firm sh all be w holly responsible. The firm has to bear full responsibility towards the fulfillment to labor law s.

15-Actual payment shall be done, as per the dimensions actually covered for repair/color etc.

16- The contract is subject to the condition that the tender shall comply with all the laws and acts of Centr al Govt., State Govt. relating contract made applicable from time to time'.

17- The consumables (HDPE film etc.) to be provided by the contractor should be of requisite quality and t heir incidental warranty/guarantee shall be taken care of by the contractor.

18-Risk clause: ICAR-CSWRI reserves the right to discontinue the service at any time, if the service are fou nd unsatisfactory by giving a show-cause to be replied within a period of three working d ays and also has the right to award the contract to any other agency at the risk and cost of current agency no excess expe nditure incurred on account of this can be recovered from Security deposit or pending bills of the Agency o r by rising a separate claim.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
