- (1) Registration certificate of the firm under the work contract of the Central Government / State Government / etc along with a valid certificate under The Private Security Agencies (Regulation) Act. The firm should be registered for providing security services in Rajasthan under The Private Security Agencies (Regulation) Act. Documentary evidence must be submitted.
- (2) Pre-Bid Interaction is must to attend by all the bidders failing which their bid shall not be qualified for technical evaluation. The meeting must be attended either by proprietor or authorized representative of the firm. If meeting is attended by authorized representative than he/she must carry an authorization letter from the concerned firm / bidder.
- (3) Preference shall be given to the firms who are providing services to ICAR Institutes.
- (4) Last 03 years continuous experience of the firm in the field of providing security services in Govt. (Cent re/State) Departments/Autonomous bodies/PSUs/PSES/Banks & Insurance Companies and year wise experience certificate with clear indication of "Satisfactory Services" for the last 03 years must be provided.
- (5) EPF and ESI registration certificate issued by Govt. of India/State Government etc. must be uploaded.
- (6) Documentary proof of minimum 40 nos. (Security Guards/Supervisors) registered under ESI & EPF deposit in the respective account.
- (7) Whether the firm has any legal suit/criminal case pending against it for violation of EPF/ESI,. An undert aking in this regard must be uploaded.
- (8) The firm must upload an undertaking that it will not charge any fees from its employees in the name of registration of its employees. The firm should undertake to provide the minimum wages along with statuto ry dues to its employees without any illegitimate deduction in their wages/salary.
- (9) Any disputes arising in this bid shall be filed at Malpura jurisdiction only.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
