1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 4- If due to the negligence of the firm, the property of the institution is damaged in the course of work, the n deduction will be made from its bill /security money

5- Labor laws have to be followed by the firm.

6- After completing the above work satisfactorily, payment of the bill submitted by you within 30 days as p er rules- will be done through From which income tax will be deducted as per rules.

7- The firm has to submit the bank account details (IFSC code no., bank account no., bank name etc.) alon g with the bill.

8- The Competent authority reserves the right to cancel the above work order at any time without assignin g any reason.

9- The contractor/agency shall not sublet the work.

10- The contractor or his deployed workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.

11- The rates to be quoted should include cost of each and every item including material cost if any, trans portation cost, manpower cost and taxes etc. The CSWRI shall not bear' any extra charge on any account whatsoever uniform, Liveries, OTA etc, if any'

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
