3. Personal Interview : 30 marks

Note:

- 1. Interested candidate(s) shall be required to be present physically at the venue to attend walk in interview on the given date & time.
- 2. If the number of applicants who are eligible in all respect for the position are higher, for the convenience of Office only top ten candidates as listed on the basis of their total marks w.r.t. the criteria as fixed for educational qualifications and desirable qualifications may be called for attending the interview.
