Kind reference is invited to this office letter of even no. dated 25th April, 2019. In this regard, it has been observed from the Reports of PFMS(EAT 02) (copy attached) that the ICAR agency users and the agencies down below ICAR are still not utilizing Government grant funds through EAT module in PFMS. This situation has been prevailing despite numerous requests and reminders from ICAR Headquarters to ensure Implementation of EAT module immediately.

It is further informed that If this situation is not rectified on immediate basis, the next installment of Govt. grant to ICAR will not be released by the Ministry of Agriculture & Farmers' Welfare, resulting in complete non-availability of funds for any purpose, including Salaries with the Council and all its Units.

Accordingly, all the ICAR Units are hereby directed again to immediately take appropriate remedial measures as per letter dated 25th April, 2019 taking EAT reports for reference and ensure full implementation of EAT module in PFMS in respect of all transactions relating to Govt grant funds. Further, in case of any difficulties, the same may immediately be brought to the notice of this office by way of detailed email at pfms.icar@gmail.com.

It is reiterated that non-compliance of the above would lead to non-release of Govt grant funds to ICAR. Accordingly, compilance is to be ensured at your end and a report in this regard shall be forwarded within 5 days of the receipt of this letter.
