The ICAR has extended medical facilities to its retired employees vide letter No. 3(1)/93-Per IV dated 22.1.99. Para 4 of that letter reads as under:-

"Medical reimbursement in respect of the indoor treatment in a Govt Hospital/Recognized Hospitals to the Institutes concerned shall be admissible provided the patient is referred for specialist treatment by the Medical Officer-In-Charge of the ICAR Dispensary. Reimbursement of such claims shall be regulated under CS (MA) Rules as applicable for Govt/recognized Hospital and to the extent admissible to the ICAR Pensioners availing CGHS Facilities in Delhi."

- 2. Several representations have been received in this regard for indoor treatment in r/o themselves and for their family members
- 3. The matter has been considered and it has been decided with the approval of Competent Authority that Credit facilities stand extended to ICAR Pensioners residing in non-CGHS Covered areas in respect of indoor treatment of pensioners and their dependents subject to the condition that they are referred by the Institutes AMA for indoor medical treatment at any of the recognized hospitals as elaborated in provision 4 of Council's letter No . 3-1/93-Per IV dated 22.1.1999.

Medical facilities for the ICAR employees-Recognition of Private Hospitals/Doctors for medical attendance/treatment.

Sir.

Para 2(2) of Council's letter No. 3(23)/82-Per. IV dated 5.4.1988 on the subject mentioned above provides that the Personnel of the Institutes/Centres which are located outside Delhi may get medical treatment in the 'Public and Private/Public Trustee Hospitals'. Such Hospitals will be identified by the Directors of the Institutes/centres and recognized with the approval of the Council. The proposals in this regard should be sent to the concerned administrative section of the Council alongwith the financial implications.

- 2. In the CJSC meeting held on 4.9.2019, it was requested by the staff side that the powers to recognize the Private Hospitals may be delegated to the IMC of the Institutes. The matter has been examined in the Council. It has now been decided with the approval of Competent Authority and concurrence of Internal Finance Division of the Council that the powers for recognizing 'Public and Private/Public Trustee Hospitals' are delegated to the Institute Management Committees (IMC) of the Institutes. Henceforth, subject to terms & conditions in this regard, no proposals for approval may be sent to ICAR Hqrs.
- 3. The details of the Hospitals recognized by the Institutes may be sent to the ICAR Hqrs for maintaining a database.

Sir.

The ICAR has extended medical facilities to its employees vide letter No. 3(23)/82-Per IV dated 5.4.88. Para 3 of that letter reads as under :-

"The Directors of the Institutes/centres which are located in towns/places where the doctors notified by the Ministry of Health and Family Welfare are not available or the distance is inconvenient for the employees may nominate 3 to 4 doctors as authorized medical attendant with the approval of the Management Committees of the Institutes subject to the condition that the Institutes do not have their own dispensary and permanent doctors".

- 2. In the CJSC meeting held on 4.9.2019, it was requested by the staff side that the services of AMAs appointed by an Institute may be allowed to be availed by employees of other ICAR Institutes located in the same city/area.
- 3. In this regard, it is informed that Council's vide letter No. 3(4)/95- Per IV dated 5.6.2009 had allowed the employees of other Institutes located in the same city/area to avail the services of the AMAs appointed by other ICAR Institutes subject to the condition that their parent Institute do not have their own dispensary and permanent doctors.
- 4. Keeping above in view, it is again reiterated that the services of the AMAs appointed by ICAR Institutes shall be availed by employees of other ICAR Institutes located in the same city/area subject to the condition as mentioned above.
