Subject : Poor Performance in implementation of Finance module of ERP & PFMS in

respect of (name of institute)

The performance of ICAR units in complying PFMS & ERP-FMS was reviewed at Council and it has been observed that the progress made in implementation of Finance Module-ERP & PFMS system in your institute is found to be very poor. Further, it is also evident that ICAR, HQ has been continuously pressing hard and issuing instructions to all ICAR's units, time and again, for implementing the FMS-MIS in all aspects. Also number of trainings, wokshops etc. have been conducted in the past for making ICAR units proficient in implementing the FMS-MIS but despite of all such efforts the progress has not been improved till date. As per the reports available, it is also noticed that ERP-FMS has not yet became operational in respect of your institute till date. Further it is also observed that the expenditure figures reported in monthly reports by your institute doesn't match with the figures reflected on FMS & PFMS implying that accounting of funds and reports are being prepared manually which is much alarming despite of the fact that ERP-FMS solution has been in place for last 04 years. Hence witnessing such poor performance of your institute despite of repeated instructions and putting every possible effort, no significant steps has been taken in this regard which is a matter of great concern.

- You are hereby directed to take every possible effort to make FMS fully operational in your institute and ensure that the expenditure figures reported to Council upto 31 Dec 2017 matches with figures in ERP-FMS & PFMS within a period of one week from the issue of this letter. In case of non-compliance of the same, subsequent remittances of grant (including salary portion) will be stopped apart from taking strict Administrative action against the erring officials and staff.
- I am happy that leave details of employees are being captured, service book has been undated, but Payroll Module is not being used which is a serious issue. You much draw your pay for the month of Feb 2010 Ullwarus wereng and Madula under FMS only. Any other mode of drawal must be avoided. We are likely to advice banks not to entertain bills for payment of salary & wages unless it is drawn using Payroll module available under FMS. You may check financial

eports as is available on http://misfms.icar.gov.in where financial reports, invoices crea payments made, service boo updated, payroll disbursals & leave details numbers as on hat available. For the convenience of yours, two statements are attached herewith i.e. Statemer Financial Report 2017-18 & Statement-II - HRMS, Service Book updated

- This is in addition to the PFMS.
- We will discuss these issues in the forthcoming meeting of Director's conference to be h in second week of March for which notice has already been issued by ADG, TC.




