- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
